SECTION 9 - PRECAUTIONS TO CONTROL EXPOSURE / PERSONAL PROTECTION

Engineer Controls: Use Local exhaust as needed.

Monitoring: Maintain breathing zone airborne concentrations below exposure limits.

Personal protective Equipment (PPE):

EYE Protection: Avoid contact with eyes, wear splash-proof chemical goggles, face shield, safety glasses (spectacles) with brow guards and side
